The job-embedded licensure program at UT Martin is delivered fully online. Technology is used throughout the courses required for completion of the teaching license. Canvas is the main platform candidates interact with coursework, faculty, and classmates. Teacher Education 730/780 requires a minimum number of lesson plans that are turned in for review to use SMART or Promethean technology. Students are also required to create and analyze an assessment administered to their students. Students in Secondary Education 730/780 must develop case studies reflecting problems that have occurred in their school. They deconstruct or analyze the consequence of the response to the action. They then take the findings of the case study and do research to determine the best practice for changing the outcome. Most job-embedded programs also require EDST 750, Teaching with Technology. This course provides a research-based overview of the use of a variety of media and technology tools as an integrated part of the teaching and learning process. Emphasis is on current technology-related issues in schools and the use of technology to promote learner-centered classroom environments.
